

MEMBERSHIP APPLICATION

Thank you for considering membership at the Bays Club.

The following is a guideline to the procedures and requirements of joining the Club.

1. Each applicant must be proposed and seconded by current Club members. Arrangements can be made for those who do not know any members of the Club for the purposes of proposing and seconding.
2. You will need to complete, in full, the application form and return it with the appropriate fee. A passport sized photograph is required for Full Member applications only.
3. Following submission of your application, you will be asked to attend an informal meeting with one of our Committee persons, who will explain the rules and give an insight to the Club and its activities. This will last no more than 15 minutes.
4. Your name and photograph will be displayed on the notice board within the Club for 14 days.
5. After the 14 day period your application will go to the next Management meeting which is held on the last Monday of each month where your application will be submitted for acceptance.
6. **Full Member Applicants** will be invited to attend a member's afternoon held on the first Sunday of the following month, where they will meet other Committee members, be provided further insight to the Club and given a guided tour of the Club. You will also be given your membership card and welcomed to the Club.

Important: If you fail to attend the first member's afternoon you will be invited to attend the next afternoon the following month. If you fail to attend the second afternoon without due cause, the Club reserves the right to return all monies paid and terminate your application.
